CITY COUNCIL MINUTES  
APRIL 21, 2010**

**PRESENT:** Parent, Bohnen, Greeder, Attorney-Scott McDonald, Maintenance Superintendent-Rick Paulson, and Clerk-Vickie Keating.

**AGENDA**

Bohnen made the motion to accept the agenda as presented, Greeder seconded the motion and the agenda was approved.

**MINUTES OF THE MARCH MEETING**

Parent moved to accept the minutes of the March meeting as pre-read, Bohnen seconded the motion and the motion passed.

**LAW ENFORCEMENT OFFICERS**

Officer Wittl introduced himself as the new night officer on duty in the Mahtomedi, Willernie area. He explained that there are some juveniles in a house on Paddington and he would like to make this house a legal nuisance.

The City will send a letter to the owners explaining that there have been several police calls to the house and the City is concerned about the issues in this house. Scott will review the legal procedures concerning a nuisance house and report back to the Council in May.

The Council explained that there are several illegal u-turns in front of City Hall, the four way stop on Wildwood Road is not always observed by the drivers and there is speeding on Warner and County 12. Officer Wittl will inform the other officers on duty to watch these areas for violations.

As summer approaches the officers will again do some sweeps that help with the problem juveniles in Willernie.

**STEVE MATTSON**

Mr. Mattson purchased Burgers, Brother's and Beer in April and he is going to change the name to Mattson's Road House. They are going to serve breakfast and lunch during the weekdays with dinner on Thursday, Friday and Saturday evenings.

The health department approved a new license; fire department has checked the kitchen equipment and the fire extinguishers have been replaced.

The restaurant opens at 8:00 a.m. and closes at 3:00 p.m. Monday through Thursday.

Mr. Mattson requested approval of a business license from the City for the new restaurant.

Bohnen made the motion to approve the business license for Mattson's Road House, Greeder seconded the motion and the motion passed.

**MAHTOMEDI REFERENDUM RESOLUTION**

Mayor Parent read the letter sent to the City by the 832 School District concerning the support for the upcoming bond issue.

After the letter was read the Council decided that it would be presumptuous on their part to decide if all the citizens in Willernie support the bond issue and the resolution would be the opinion of the Council not the entire City.
