CITY COUNCIL MINUTES
JUNE 19, 2013**

PRESENT: Parent, Bohnen, Miller, Greeder, Baglio, Attorney-Scott McDonald,
Maintenance Superintendent-Rick Paulson and Clerk-Vickie Keating.

ADOPTION OF AGENDA

Under new business the Sheriff's Meeting was added to the agenda. Miller moved to approve the agenda with the addition, Bohnen seconded the motion and the motion passed.

MINUTES OF THE MAY MEETING

Bohnen moved to accept the May minutes as pre-read. Baglio seconded the motion and the motion passed.

PUBLIC COMMENTS

No one was present for public comments at the June meeting.

LAW ENFORCEMENT OFFICERS

Officers Wittl and Wieland attended the June Council Meeting to report on the activities in Willernie.

The City has been quiet the last few months and the officers are pleased with the lack of activity.

The Council asked the officers to check on the illegal u-turns in front of City Hall, the four way stop sign on Wildwood Road and the activity in Milnar park. The officers will check on these areas, however, they wanted the Council to know that fewer tickets have been issued in the City during the last few months.

GORDY'S

Gordy attended the meeting to request permission for the August 17th tent event. The liquor license is extended to the blocked off parking lot, Washington County Sheriff's Office is notified of the event and the band shuts down by 11:30 p.m.

Bohnen moved to allow Gordy to host the event as long as the above conditions are met, Miller seconded the motion and the motion passed.

Gordy also has asked his staff to be respectful concerning the parking on Wildwood Road so that his employee's cars do not interfere with Domino's and Lakeside Floral business hours.

Gordy will talk to Earle of Sandwiches about extra parking in their lot so that the businesses will not have any problems with customer parking.

SHERIFF'S MEETING

Parent attended a meeting at Mahtomedi City Hall concerning the Sheriff's contract. Currently, Washington County services Mahtomedi, Dellwood and Willernie. Birchwood is going to join the other cities which will reduce the cost of the contract for each of the participating cities.

Mahtomedi will research the numbers and contact the other cities with the savings to each City.

STORAGE BUILDING ORDINANCE

Scott will review the storage building ordinance proposed by the building inspector and make suggestions at the July meeting.

GOLF TOURNAMENT UPDATE

Scott sent out the letters to the businesses in Willernie and invited the police officers to the tournament.

Parent and Miller will meet with Jerry after the 4th of July to go over the details of the tournament and make sure everything is in place.

Miller has requested a quote on printed golf balls and will report back in July on the cost.

GRANTS

Miller is still waiting for a return call from the grant executive. He will report on the progress in July.

RICK REPORT

The bid from Schifsky was in the Council's packet. Rick suggested waiting on the overlay to Chatham for another year due to the expense. There have been problems with the catch basin and the culverts requiring repair this year.

None of the street work can be done until the ground is dry for a few weeks.

Scott then reviewed the Waste Contract with the Council. There are some questions on the contract that Scott will discuss with Advanced Disposal before the mayor signs the contract.

APPROVAL OF THE BILLS

Baglio moved to approve the bills, Bohnen seconded the motion and the motion passed.

ADJOURNMENT

Bohnen moved to adjourn the meeting at 8:43 p.m. Miller seconded the motion and the meeting was adjourned.
